RECORDING FEES FOR DOCUMENTS

- Fees include up to four pages, four names, one acknowledgement and one parcel
- Each name over four \$0.50 per name
- Additional pages over four \$2.00 per page
- Each additional acknowledgment \$0.50
- Each additional parcel \$0.50
- Statement of Value \$2.00
- All documents listed below will require a \$10.00 parcel identification fee for the first parcel. Any additional parcels certified in the same document will be charged a fee of \$2.00 per parcel. Multiple documents being recorded for the same parcels (i.e. deed, mortgage, assignment, etc) will be charged \$10.00 on the first parcel and \$2.00 on each parcel on each additional document.
