<b>RECORDING FEES FOR DOCUMENTS</b>	
<ul style="list-style-type: none"> <li>• Fees include up to four pages, four names, one acknowledgement and one parcel</li> <li>• Each name over four \$0.50 per name</li> <li>• Additional pages over four \$2.00 per page</li> <li>• Each additional acknowledgment \$0.50</li> <li>• Each additional parcel \$0.50</li> <li>• Statement of Value \$2.00</li> <li>• All documents listed below will require a \$10.00 parcel identification fee for the first parcel. Any additional parcels certified in the same document will be charged a fee of \$2.00 per parcel. Multiple documents being recorded for the same parcels (i.e. deeds, mortgages, assignments, satisfactions, releases, etc) will be charged \$10.00 on the first parcel and \$2.00 on each parcel on each additional document. This charge will change effective October 3, 2011.</li> <li>• <b>Effective October 3, 2011 the fee for each PIN certification shall be \$10.00. If a document contains multiple parcels, the cost for each PIN certification shall be \$10.00 per PIN certified</b></li> </ul>
