Commissioners' Other Business

Commissioner Corey O'Brien: Extreme fiscal mismanagement from certain previous administrations has led to the current tax increase, which has been explained numerous times at public meetings, and hearings. Our tax system is not structured to support an additional 10-12 million debt service that was borrowed from 2004-2008. Over 30 million in expenditures have been cut since 2008. Row Office elimination- the savings to the taxpayer WOULD have been at least 2 million. The offices have very little relevance in modern society and should have been eliminated 20 years ago.

Commissioner Patrick O'Malley: Bocce tournament; Arts on Fire; Flag Day ceremony at the courthouse. Congratulations to Old Forge and Abington Heights baseball teams, along with Valley View girl's softball. And a Happy Fathers Day to all!

Commissioner Jim Wansacz: First ever Lackawanna County Job Fair at PNC Field-1600 job openings, with 163 vendors. Great job to Old Forge, Abington and Valley View teams. Our County Government must be more efficient- over 2 million dollars in savings annually was voted down with the Row Office Referendum; it was not a power grab, we were trying to shrink the government bureaucracy. Increased debt service, efficient budget cuts and public service. For the election in either November or May of next year, a decision will be made.
