"This is a very entrepreneurial approach to attracting business and jobs that the county has taken," said SBA District Director David Dickson, responsible for the 40 eastern counties of Pennsylvania. "Lackawanna County is leading the way with this very unique and innovative way to stimulate local economic development – it's unlike anything else I've seen in the nation."

Eastern Pennsylvania Lackawanna County began its Small Business Administration Loan Fee Waiver Program Jan. 1 to promote economic development, spur local economic growth, and encourage the private

sector to create family-sustaining jobs in Lackawanna County. The County allocated funds from its \$1.25

million economic development budget line item for the SBA program to assist in the projects of qualified businesses working with a qualified lender.

"The community has witnessed an increase in SBA loan transactions," Commissioner Wansacz said. "The program has helped to create jobs, diversify our economy and generate revenue for the community-at-large. We are committed to promoting private sector growth for the area, and the waiver program has been very helpful in accomplishing this goal."

"This is all about creating and retaining jobs. This program helps to address our long-term, higher-than-average, unemployment rate," Commissioner O'Brien said. "The waiver program offers a great way to diversify our economy by supporting the retention and growth initiatives of our local business community."

"We want to help businesses prosper because if they do everyone benefits. We need jobs here and this is a step towards attracting new opportunities," Commissioner O'Malley said.
