

Instructions Regarding EO 2012-16

On Friday, November 2nd, 2012, Governor Tom Corbett signed Executive Order 2012-16, which provides relief for Emergency Responders “whose absence from their county of residence on Election Day is required by order of their employer or other organization and is directly related to efforts of the elector’s employer or other organization with which the elector is associated to recover from the effects of Hurricane Sandy.”

Below is a list of resources and information you may find useful in ensuring that your employees exercise their right to vote in the coming days.

Schedule of EO 2012-16

Friday, November 2nd through Monday, November 5th at 5:00 p.m.

- Emergency Responder Qualified Absentee Electors (ERQAs) may apply for absentee ballots applications via fax, email, mail or hand delivery. These applications signed and delivered on behalf of the voter by an immediate family member.
- After receiving absentee ballot applications via fax, email, mail or hand delivery. County Boards of Elections begin emailing absentee ballots - including a scanned portion of the outside of the envelope which must be completed – to ERQAs

Due by Monday, November 5th at 5:00 p.m.

- Absentee ballot applications and completed absentee ballots MUST BE POSTMARKED.

Due by Tuesday, November 13th

- Completed absentee ballots must be received in the mail by ERQA’s County Board of Elections.

Materials Needed By ERQAs

In order to assist your ERQAs, it is important to make computers with internet access, fax machines, printers/copiers, envelopes and stamps available to your employees. Please also make the attached contact information for county Boards of Election available at each location.
