#### **CURRENT SITUATION**

As of January 30, 2020, the World Health Organization (WHO) has declared the novel coronavirus outbreak a global health emergency. WHO has officially named the 2019 novel coronavirus COVID-19. As of March 11, 2020, WHO has declared the novel coronavirus a pandemic.

PADOH continues an incident command structure to coordinate monitoring, response, and messaging. The Department Operations Center is located in room 112 of the PEMA building. PADOH is coordinating with other state agencies, as needed. These agencies include the Dept. of Human Services, PEMA, Dept. of Education, PASSHE, PSP, DMVA, OA, and Agriculture. Communications personnel from various agencies have established a virtual Joint Information Center to address inquiries related to COVID-19.

Currently, 116 countries have confirmed cases of the virus.

As of March 7, 2020, The Pennsylvania DOH State Lab in Exton has confirmed the state's first presumptive positive COVID-19 cases, and Governor Wolf has signed the COVID-19 Disaster Declaration.

As of 1800, there are 28 presumptive positive cases in Pennsylvania. Community spread is implicated in several states and cases in long-term care facilities have been noted in Washington state, and there are 38 deaths to date in the United States.

As of March 12, 2020, Governor Wolf ordered mass closings in Montgomery County. These closings include all schools, community centers, gyms, entertainment centers, and non-essential retail. All critical infrastructure will remain open.




