Summary (BLUF): This Incident Report covers any County, State, or Federal level COVID-19 related information affecting Region III.

Federal:

- The White House is recommending federal employees limit all travel to "mission critical" travel, in addition to the international restrictions currently in place.

DC:

- Restaurants, taverns, nightclubs, and multi-purpose facilities must comply with the Department of Health's Emergency Rulemaking to Prohibit Mass Gatherings effective March 13, 2020.

Maryland:

- The State of Maryland closed all casinos, racetracks and simulcast facilities. Emergency Order.
- Howard County has declared a State of Emergency.

Pennsylvania:

- Luzerne County has declared s State of Emergency effective immediately.
- McKean County has Partially activated.

Virginia:

- All Fairfax County Senior Centers and Adult Day Health Care Centers are closed until further notice.
- Fairfax County Public Schools (FCPS) closed all buildings until further notice. Essential personnel are asked to report to work.
- Dan on special public events over 100 people statewide. (i.e. events that bring together more than 100 people in a single room or a single confined space at the same time without room to spread out. Parades, festivals, gatherings in auditoriums, stadiums and or conferences).
- Goochland County has declared a State of Emergency.
