2020 – 2021 FORECASTED AND ACTIVE WINTER WEATHER MESSAGING

PURPOSE

The purpose of this document is to provide statewide Dynamic Message Sign (CMS) guidance for winter weather operations. This document is to be used to supplement the CMS Guidelines, dated 2013, and is intended for use by all Traffic Management Center (TMC) personnel statewide.

INTRODUCTION

Due to the importance of providing accurate, clear and consistent information to the public on winter weather road conditions, CMS messages posted for all winter road conditions shall be standardized statewide. To provide the best guidance for motorists during adverse weather, TMCs throughout the Commonwealth may utilize CMS to convey cautionary messages about potentially hazardous driving conditions, due to inclement winter weather, that meet the criteria outlined below.

The primary purpose of the following road weather communications is to provide both preemptive and reactive warnings regarding current or nearterm adverse conditions that will require motorists to make safe & effective decisions while driving in addition to providing accurate and timely information about forecasted and real-time weather conditions.

It is recommended that TMCs statewide utilize the National Oceanic and Atmospheric Administration (NOAA) guidance for all alerts (e.g. advisory, warning, watch). This information can be attained at <u>www.noaa.gov</u>.

To maintain the attention and safety of motorists, TMCs are encouraged to utilize the following CMS message types for inclement winter weather: (Reference Pages 2 & 3 – Pre-Event, Active Event, and Advisory Speed and Vehicle restriction messages for further information and guidance)

PRE-EVENT MESSAGES

Pre-Event Messages are intended to provide situational awareness to the traveling public regarding forecasted inclement weather and the hazardous roadway and driving conditions expected throughout the imminent significant winter weather event.

The intent of these messages is to encourage motorists to modify future travel plans or, in some cases, avoid travel all together, in an attempt to improve roadway mobility and most importantly, enhance the safety of the traveling public throughout the Commonwealth.

Pre-event messages may be used **24-hours prior** to the expected arrival of imminent winter weather. Preevent messages should be utilized <u>only</u> when a National Weather Service alert is in effect for the county, district, and/or region. *TMC personnel (Auxiliary/Regional) may need to coordinate Pre-event messaging with neighboring states, other Auxiliary/Regional TMCs, the Statewide Traffic Management Center (STMC), PennDOT Area Command and/or other transportation agencies and stakeholders.*

A final judgement call will be made by PennDOT Leadership and/or TMC Management as to whether the CMS Pre-event messages will be approved and posted.

It is important to note that forecasted pre-event messages on CMS are not intended to be used as "weather reports" for traveling motorists. The purpose of preemptive messaging is to provide timely and accurate information in addition to situational awareness regarding the forecasted winter weather and the inclement driving conditions to be expected.

ACTIVE EVENT MESSAGES

Active Event Messages are intended to provide *real-time* situational awareness to the traveling public regarding inclement weather and the hazardous roadway and driving conditions throughout the entire significant winter weather event.

The intent of these messages is to encourage motorists to make safe & effective decisions while traveling in addition to providing accurate and timely information about real-time weather conditions throughout the Commonwealth. These Active Event Messages are to be used to warn the traveling public of actual and potentially unexpected road/weather conditions along their traveled routes (e.g. Drifting/blowing snow, icy conditions, reduced visibility, etc.). Active event messages may be used throughout the inclement winter weather event in its entirety.

It is important to note that when posting active event CMS messages regarding winter weather road conditions, it is imperative that TMC personnel maintain a high-level of situational awareness throughout the entire significant weather event. This will ensure the appropriate messages are displayed, updated, and/or removed as conditions change. *This high-level of situational awareness may require enhanced communication between all TMC personnel (Auxiliary/Regional), the Statewide Traffic Management Center (STMC) and PennDOT Area Command.*

ADVISORY SPEED AND VEHICLE RESTRICTION MESSAGES

Advisory Speed with Commercial Vehicles Right Lane only* and Vehicle Restriction Messages shall <u>only</u> be utilized at the direction and approval of PennDOT Area Command

Implementing temporary speed limit reductions* and vehicle restrictions involves multifaceted coordinated efforts with multiple state agency stakeholders such as: the Pennsylvania State Police (PSP), PennDOT Field personnel, TMCs (Auxiliary/Regional), the STMC, as well as PennDOT Area Command.

Advisory speed messages* and vehicle restrictions may but are not limited to any adjustments made in "boundaries" and/or "areas of impact" (AIO) found necessary to properly reflect and adjust to changing weather and/or road conditions throughout the entirety of the significant winter weather event.

Advisory speed* and vehicle restriction messages will <u>only</u> be posted, modified, and/or removed when directed by PennDOT Area Command.
