2. PROJECT OVERVIEW

Lackawanna County is requesting the fabrication of 50 new vendor huts of two different sizes painted white for vendors to sell products for the annual Lackawanna County Holiday Market and other events.

Fabrication is based on design of prototype (see Exhibit B & C) The vendor huts will be mobile rigid weather resistant multi-use structures to be erected on concrete/asphalt,

collapsible and capable of facilitating electricity, movable by lift and capable of being stored in shipping containers.

A mandatory pre-bid meeting will be held on July 23 from 11:00am-12:00pm. at the Electric City Trolley Museum at 300 Cliff St. Scranton PA and the prototype will be on display at Sun.-Mon. from 9am-4pm from July 23, 2021, until Aug. 10, 2021.

3. ABOUT THE DESIGN OF THE PROTO-TYPE

The prototype was designed based on considering factors of weather, ease of mobility for storage and set-up, security, vendor requests and sustainability of structure. Specifically, the following was considered:

- Be mobile with footprint no larger than 24" x 90" with a height no larger than 96" when collapsed for transport/storage.
- Allow for ease of vendor set up and tear down.
- Fit in shipping container for storage.
- Movable by lift truck (for transport/storage)
- Minimal tools and manpower to erect.
- Lockable and secure when erected.
- Wind and weather resistant.
- Capable of facilitating electric lighting.
- Meet all required governing standards for mobile event structures.

4. SCOPE OF WORK

Fabrication services for 50 Vendor huts painted of two different sizes based on specifications from design specs and prototype to be completed and delivered by December 2, 2021, to 200 N. Washington Ave. on Courthouse Square the day before event. Delivering directly to the event location will streamline set-up.

of Units and Dimensions:

- 20 Large Units: 90" wide x 96" tall x 108" deep
- 30 Small Units: 90" width x 96" tall x 66" deep

Both units must collapse to 90" x 96" x 24"

Materials to Be Used

Lumbar and Aluminum. Aluminum will be outside of unit to ensure weather protection. See specifications for thickness and other information.

Electricity Facilitation

Design allows for opening for vendor access to electricity.

Mobility

Units must be movable by a lift for transport and storage.
