AN ORDINANCE of the County of Lackawanna, Pennsylvania Establishing the Lackawanna County Department of Health and Human Services.

BE IT ORDAINED AND ENACTED, and it is hereby resolved and enacted by the Board of Commissioners of the County of Lackawanna Pennsylvania as follows:

SECTION 1: The establishment of a single county Lackawanna County Department of Health pursuant to Local Health Administration Law (16 P.S. §12001, et seq.) under the umbrella of the Lackawanna County Department of Health and Human Services. The Lackawanna Department of Health will be responsible for foundational programs, Communicable Disease Control, Prevention and Health Promotion, Environmental Health, and Access to Clinical Preventative Services. The purpose of the Department of Health is to preserve, promote and protect the health, safety and well-being of the people and the environment in the county. The integration with Human Services will leverage resources and partnerships to allow the county to provide physical health as a component of overall health and well-being.

**SECTION 2:** This ordinance shall take effect upon enactment.

Dear Acting Secretary Beam:

The Board of Commissioners of Lackawanna County respectfully request a Certificate of Approval to proceed with the establishment of a County Department of Health pursuant to 16 P.S. §12001, et seq., commonly cited as Act 315.

Lackawanna County desires to establish a single county Lackawanna County Department of Health (LDOH) under the umbrella of the Lackawanna County Department of Health and Human Services. The Lackawanna Department of Health will be responsible for foundational programs; Communicable Disease Control, Prevention and Health Promotion, Environmental Health and Access to Clinical Preventative Services consistent with Act 315 and associated legislation. However, the integration with Human Services will marshal resources and partnership opportunities from its categorical departments, i.e., Area Agency on Aging, Behavioral Health/Intellectual Disabilities/Early Intervention, Drug and Alcohol Programs, Housing, and Office of Youth and Family Services.

This will also allow the county to assess physical health as a component of overall health and well-being including behavioral health and other Social Determinants of Health with the goal of promoting health, well-being, and safety as well as increasing health equity among our most vulnerable populations. The included assessment of Lackawanna County health status and needs as well as a preliminary plan, outline our critical arguments in support of establishing a county department of health. Should you approve this request we would like to further refine and develop this plan with technical assistance from the Pennsylvania Department of Health as well as further engaging members of the community.
